Description

This module provides an overview on the political economy issues in the analysis of contemporary Southeast Asian. The course takes a comparative historical, sociology, economy, security approach to Southeast Asian politics, beginning with a close treatment of the transformation of state structures, class and identity formation, and the emergence of modernity and nationalist consciousness during the colonial era. Through a series of paired comparisons, moreover, the course treats key issues in the modern politics of Indonesia, Singapore, Malaysia, Timor-Leste, and the Philippines. The course also focuses on contemporary themes such as aid and investment politics, civil society, human rights, class conflict and struggles over religious, ethnic, and regional identities in the region.

Objectives and Learning Outcomes

By the end of the course, students should be able to demonstrate that they can:

- Examine and assess in a comparative mode the politics and government of key countries in mainland and maritime Southeast Asia.
- Compare and contrast the formation of modern nation-state, evolution of political institutions, system of governance, contours of political development and decay, contestation of power, and changing politico-economic configuration of countries in the region.
- Critically evaluate the linkage between politics and economic changes on the one hand, and social and cultural transformation on the other hand, of key countries in the region.
- Understand and explain the peculiarity of the concepts of democracy, legitimacy, authoritarianism, political development, and nation-state building within the milieu of Southeast Asian; and
- Comparatively analyses the broad contours of political change and conflict in maritime and mainland countries of Southeast Asia.

Description

This course aims to unfold the relevance of gender in the study of international relations by approaching gender a complex and contested social construction. Gender is social construction which has very significant impact in economic, leadership, politics and public policy. The course examines how gender construction shapes the existing global political structure and the gendered impacts of the existing political structure for both men and women. The course explores gender issues in both private and public realms by unpacking several topics, namely gender and leadership, gender and development, gender and political representation, gender and foreign policy, and gender, peace and security. In providing practical examples, the comparative study on gender and political representation between Indonesia and Taiwan will be examined, particularly concerning women in leadership and parliament – including gender quota debates.

Objectives and Learning Outcomes

The objective of the course is to provide students with both conceptual and practical understanding on gender and politics and, through a wide range of issue areas, demonstrate gender analysis of global issues under the prevailing global political structures.

By the end of the course, students should be able to:

- Understand the concept of gender and its relevance in the study of international relations;
- Examine how gender construction shapes the existing global political structure
- Examine the gendered impacts of the existing political structure for both men and women
- Apply gender analysis in understanding gender issues
