- This Summer Course is offered to any individual who are interested in learning law and sharia in particular issues.
- This Summer Course will run for a total of more than three weeks from 29th of July until 23rd of August 2023.
- All participants will take a compulsory course that is the Introduction to Indonesian Legal System. In addition, SCLS offers several elective courses such as Medical Law and Ethics, Constitutional Law, Commercial Law, Competition Law, and Islamic Banking and Finance (the class will be opened if minimum participants have been fulfilled).
- An academic transcript will be granted for participants who attend the class (minimum 70%) and pass the assignments as well as the examinations.
- The tuition fee is USD 600. This payment includes airport pickup and carriage to the airport, lunch on weekdays, a whole package of social and cultural activities, and accommodation in University Residence.
